CAMP GUIDELINES

Day Camp is from Noon to 5 pm, Monday- Friday
Glen Oaks Summer Day Camp is on a first come, first serve basis.

Payment Policies:

Payment for the initial week of planned attendance is required at the time of sign-up to reserve your child's spot. There is a discount if you pre-pay for 4 weeks in advance. There is also a sibling discount. ALL PAYMENTS ARE DUE BEFORE NOON on the Monday of each session.

Drop-ins:

Glen Oaks does allow daily drop-ins to Day Camp. The ability to drop in will be limited to the amount of children that have pre-registered for each season and how many available open spaces are left. We maintain ONE day camp staff to TEN children. In order to be staffed appropriately, you must speak with the Day Camp Director or Club Manager to get approval. Drop in rates are:

- \$20/day for Members
- \$30/day for Non-Members

Cancellation and Refunds:

In order to qualify for a refund of day camp fees, you must notify the manager of the cancellation ONE WEEK PRIOR to the beginning of that weekly session. We will consider refunds for late notification for medical reasons only. This policy is designed to ensure we are able to give our employees adequate notice of scheduling and ensure adequate staffing.

Behavior:

Children must follow directions given from the Day Camp Director and staff, lifeguards, and Glen Oaks Management. The parents will be called to pick up their children early if they are not acting appropriately. Repeated inappropriate behavior could result in dismissal from the day or entire week without a refund of fees.

Attire:

- Children should wear comfortable clothing.
- If allergic to bee stings, please have your children wear shoes at all times, except when swimming.
- A swimsuit and towel are needed each day.
- Please provide sunscreen for your child (This will be applied several times during the day).
- Please label all belongings.

Attendance:

- Parents must sign their children in and out each day. The sign in sheet will be located at the snack bar or at the day camp pop-up.
- Summer camp hours are from Noon-5pm
- Please note: IF CHILDREN ARE NOT PICKED UP BY 5 PM, THERE WILL BE A LATE FEE CHARGED OF \$25 FOR EACH OCCURANCE.

Lunch and Snacks:

Children need to bring their own lunch.

-Glen Oaks will provide water and a healthy snack each afternoon.

-You can set up a pre-paid snack bar card and children will be allowed to purchase ONE item from the snack bar during snack time.

Daily Schedule:

Each week has a theme. There will be group activities, arts and crafts, swimming, and a variety of other fun-filled activities. Below is a tentative schedule. This is subject to change based on attendance and other factors.

AGREEMENT WAIVER AND RELEASE

It is further agreed that this waiver, release, and assumption of risk is to be binding on my heirs and assigns. I agree to indemnify and to hold the above person or entities free and harmless from loss, liability, damage, cost or expense, which they may incur as a result of my death or injury or property.
